- 4. Promote the AWS Academy Program to all institutions, students and other stakeholders via an outreach strategy (which may also include sharing regular updates about the AWS Academy program via circulars/notifications)
- 5. Facilitate educator workshops/ seminars for institutions nominated for AWS Academy.
- 6. Participate in social media promotion to build momentum for this Project. Participate in any press event jointly deemed appropriate by TNSDC and AISPL, as well as actively promote the AWS Academy Program through its web sites, promotional materials and other marketing activities.


